### Mills High School Music Department Tour Behavior

Students are reminded that this trip is an extension of the classroom, and all San Mateo Unified High School District Rules and Regulations apply 24 hours a day throughout the course of this trip.

- *Alcohol and drugs* are strictly forbidden. There will be no possession or purchase of any items that may be considered drug and/or alcohol paraphernalia (including souvenir shot glasses, etc.).
- There will be absolutely *no smoking of tobacco, e-cigarettes, or other products that produce a vapor or smoke* during this trip - anytime, or anywhere.
- *Prescription and non-prescription medications* are to be administered through a SMUHSD employee (Ms. Kovak) only during the course of the trip. All medication forms must be submitted in advance of the trip. All medications must be submitted to the SMUHSD designated employee prior to trip departure in a Ziploc bag along with a 3 X 5 index card clearly defining the administration of the given medications.
- The possession or purchase of any weapon or item that could be considered or look like a weapon is strictly forbidden.
- Students **are not to ride any form of transportation** other than the transportation officially provided by Mills High School. Any exceptions must be designated by the director and require direct chaperone supervision and accompaniment. **IMPORTANT:** Students can only be released to their legal guardians while on field trips.
- Students are not permitted to enter any hotel room other than their assigned room reserved by the Mills High School group. Persons not directly associated with the Mills High School group are not permitted in any rooms reserved and occupied by the Mills High School group.
- Students are not allowed to visit each other's hotel rooms at any time.
- Students will be in their rooms for a room check 15 minutes before curfew. Between curfew and wake up, no student is to leave their room. No exceptions.
- All curfews and schedule information will be listed in the trip itinerary. Students are responsible for all information in that itinerary, and any changes that may be made.
- *All venue rules and regulations* must be strictly followed. (dress, behavior, volume, etc.) There will be no pay per view services, outside phone service, or any other service that requires a financial charge to the room. All venue premises must be treated with the utmost care and respect, and use common sense.

- Students are required to **be on time** - "If you're early, you're on time. If you're on time, you're late."

- *Personal electronic devices* must be used with headphones, no speakers. This applies in transit as well as in the hotel rooms.
- In the resort, at rest stops, and during down time at the hotel, students may have the opportunity to move around freely. The distances and boundaries will be established and strictly enforced upon arrival at the location. **Always travel in groups with at least one point of contact - never alone.**
- If an emergency arises, student are to call their chaperone immediately. Students' hotel room doors will be taped at curfew; if the tape is broken, it will be assumed that the students in that room have left the room during the night and disciplinary action will be taken.
- Students are expected to follow all COVID safety policies as set by SMUHSD and venues.

The chaperones are important to the success of our trips, and they are in charge! Please show them courtesy and respect. If they ask you to do something - **DO IT**, no argument! If you disagree, you still need to follow the instructions, and see Mr. Gregoric at a later time to discuss the matter.

**Disciplinary Steps (in order of severity)**

1. "Detention" with school admin staff.
2. Parents will be contacted.
3. Severe infraction of the rules (drugs, alcohol, smoking/vaping, fighting or stealing) will result in immediate student detention (at hotel with a Trip Staff) and will be reported to the school administration for enforcement of school discipline policy upon return. In extreme cases, parents will be contacted to pick up the student.
